


Q1 How likely is it that you would recommend attending the Faculty Leadership - Hybrid Event to your colleagues?



Q2 Overall, how would you rate the Faculty Leadership Institute - Hybrid Event?





















Q18 How did you attend the hybrid Plenary Session?











Q25 How helpful was the ASCCC staff?







Our local academic senate has had increased participation and engagement by providing members a virtual option for attending our local senate meetings. In our transition back to in-person meetings, we're wrestling with how we can continue to accommodate members with disabilities and other challenges which may make it hard for them to attend in-person meetings. During the Brown Act session, several comments were made which felt insensitive to senate members who may require continued accommodations in order to participate. There seemed to be, from my perspective, an underlying assumption that senate members for whom in-person attendance was a challenge were somehow trying to "skirt" Brown Act policies. I would request that the ASCCC leadership try to be aware of and sensitive to all types of differences, including those related to ability and disability, in future sessions. 














