What is Accreditation?

Accreditation is the process for evaluating and assuring the quality of education used by the American Accredited higher education community.

Accreditation is a voluntary system of selfregulation developed to evaluate overall educational quality and institutional effectiveness and assures ...

- the public that accredited colleges meet the standards
- education earned is of value to the student
- employers, trade or profession-related licensing agencies, and other colleges and universities can accept a student's credentials as legitimate

Accrediting Commission for Community and Junior Colleges

The ACCJC assures the educational community, the general public, and other organizations and agencies that an accredited institution . . .

- has clearly defined objectives appropriate to higher education
- has established conditions under which their achievement can reasonably be expected
- appears in fact to be accomplishing them substantially
- is so organized, staffed, and supported that it can be expected
 - to continue to do so

Elements of the Accreditation Process

Published Set of Standards

Expectations for colleges and districts

Self-Evaluation

 Written reflection of how well institution complies with standards

Peer Review

•Accreditation review conducted primarily by faculty and administrators from peer institutions

Elements of the Accreditation Process

Site Visit

•Team of volunteers from peer institutions visits the college and evaluates the accuracy of the self-study


Action

- •The ACCJC makes a determination of status:
 - (re-)affirmation of accreditation
 - warning
 - Probation
 - show cause

Monitoring and Oversight


•On-going cycle of review (every 6 years), mid-term reports, substantive change reports.



Structure of the analysis of each of the Standards

- Descriptive summary
- Self evaluation
 - analyze and systematically evaluate its performance against the Accreditation Standards and its institutional mission.
- Actionable improvement plans
 - integrated into the institution's continuous evaluation and planning processes.

Provide evidence of ...

- Student achievement
- Student learning outcomes and assessment
- Quality program review
- Quality of student support services
- Financial performance and integrity
- Evidence of compliance with other areas related to federal requirements*
