**2022-2023 PROPOSED ASCCC INSTITUTES AND PLENARY SESSION DATES**

**Approved December 6, 2019 Executive Committee Meeting**

MSC (Aschenbach/Curry) to authorize the office to contract hotels for Fall Plenary Session, Spring Plenary Session, Faculty Leadership Institute, and Curriculum Institute for up to five years in the future, taking into account the area rotation of Plenary Session and to authorize the office to enter into MOUs with partner organizations for institutes dependent on external funding.

**A. President's/Executive Director's Report – 30 mins., Davison/Mica**

Mica submitted a written report. Mica shared updates and registration numbers for upcoming events. The office is looking to hire Austin Webster as an advocate and consultant for ASCCC in order to support legislative efforts.

Davison reported on the recent ICAS meeting and discussions on the AB 928 transfer pathway that has been renamed California General Education Transfer Curriculum (CalGETC). Davison also shared information from the last Board of Governors meeting and as well as provided a brief update on the Governor's May budget revise. The updated Executive Director evaluation and new contract have

been submitted from the closed session during the May 6, 2022 Executive Committee Meeting.

**B. Foundation President’s Report – 10 mins., Curry**

The Foundation did not meet last month but will continue to celebrate the group’s efforts from this past academic year. Curry is preparing to transition the group to Vélez’s new leadership.

**C. Liaison Oral Reports *(please keep report to 5 mins., each)***

Liaisons from the following organizations are invited to provide the Executive Committee with updates related to their organization: American Association of University Professors (AAUP), ASCCC Caucuses: Small or Rural College Caucus, LGBTQIA+ Caucus, Latinx Caucus, Black Caucus, Asian Pacific Islander (API) Caucus, Womxn’s Caucus, California Association of Administration of Justice Educators (CAAJE), Community College Association (CCA), California Community College Independents (CCCI), Chief Council of Librarians (CCL), California Federation of Teachers (CFT), CCCCIO, FACCC, the RP Group, and the SSSCC.

Pam Mery, RP Group Liaison, submitted a written report. Mery provided information on the Institutional Research, Planning, Effectiveness (IRPE) Summer-to-Summer Institute 2022-23 as a professional development opportunity.

Bethany Tasaka, ASCCC API Caucus Chair, provided an oral report. The caucus did not meet last month but is expected to reconvene in Fall 2022. Members celebrated API Heritage Month and will continue to celebrate API heritage throughout the year. Tasaka shared discussions on disaggregating the API community to better support members. The caucus submitted a rostrum article written for the April 2022 rostrum edition.

paper including the expansion of the equity element in distance education. The committee shared suggestions on specific courses and areas of emphasis in order to highlight the difference of impact. The paper will continue to be developed and transitioned to the 2022-23 Online Education Committee.

No action by motion was taken on this item.

### BACKGROUND:

Since 2016, ASCCC has organized a Legislative Advocacy Day to inform legislators and staff about the statutory and regulatory role of the Academic Senate of California Community Colleges as it relates to academic and professional matters and to advocate for ASCCC priorities. Additionally, ASCCC leadership regularly engages with legislators and staff, both proactively and in response to their inquiries. A proposal for ASCCC’s 2023 Legislative Advocacy Day will be presented at a later Executive Committee meeting once the Legislation and Advocacy Committee has met.

As a result of term limits enacted with Prop 28 in June 2012, post-2020 Census redistricting, and an increasing number of legislators seeking other opportunities, more than 25% of legislators will be new in 2023. The loss of at least 33 (of 120) legislators ([CalMatters](#), March 12, 2022), including some who have frequently consulted with and are allies of ASCCC, creates a need and an opportunity to build new relationships with the incoming legislators and their staff.

Subsequent to dialog with Austin Webster, ASCCC’s new legislative advocate, and ASCCC leadership, **ASCCC Executive Committee is being asked to consider holding a meet and greet event in Sacramento the evening of Wednesday, January 11, 2023** for new legislators, legislative leaders, and their staff with the intended outcome of fostering relationships with these targeted attendees. It would also be an opportunity for ASCCC Executive Committee members to share the ASCCC purview on academic and professional matters as well as the work ASCCC is doing on behalf of California Community College students and faculty.

### **[AB 1705 \(Irwin\)](#)** – Seymour-Campbell Student Success Act of 2012: matriculation: assessment

(1) Existing law establishes the California Community Colleges, under the administration of the Board of Governors of the California Community Colleges, as one of the segments of public postsecondary education in this state. Existing law, the Seymour-Campbell Student Success Act of 2012, provides that the purpose of the act is to increase California community college student access and success by providing effective core matriculation services of orientation, assessment and placement, counseling, and other education planning services, and academic interventions. The act requires a community college district or community college to maximize the probability that students will enter and complete transfer-level coursework in English and mathematics within one-year.

This bill would, among other things, instead require a community college district or community college to maximize the probability that students will enter and complete transfer-level coursework in English and mathematics within a one-year timeframe of their initial attempt in the discipline, and for a student with a declared academic goal, that the transfer-level coursework satisfies ~~a requirement~~ *the English and mathematics coursework requirements* of the intended certificate or associate degree, or a requirement for transfer within the intended major, within a one-year timeframe of their initial attempt in the discipline. By July 1, 2023, if a community college places and enrolls students into transfer-level mathematics or English coursework that does not satisfy a requirement for the student's intended certificate or associate degree, or a requirement for transfer within the intended major, the bill would require the community college to verify the benefit of the coursework to the students, as specified.

(2) The act requires community college ~~district~~ *districts* or community ~~college~~ *colleges* to use, in the placement of students into English and mathematics courses in order to achieve this goal, one or more of the following: high school coursework, high school grades, and high school grade point average. The act requires colleges to apply multiple measures in the placement of all students to ensure that either low performance on one measure may be offset by high performance on another measure or that the student can demonstrate preparedness based on any one ~~measure~~. *measure and authorizes the Board of Governors of the California Community Colleges to establish regulations governing these and other measures, instruments, and placement models that achieve this goal.*

This bill would require that high school transcript data be used as the primary means for determining placement in transfer-level English and transfer-level mathematics ~~courses, and courses~~ *and that self-reported high school information be used if there are issues with obtaining or using high school transcript data, as specified. The bill* would limit the use of multiple measures *and the enrollment into noncredit coursework* by colleges in the placement and enrollment of students, as provided. *The bill would require the board of governors to establish those placement regulations to achieve the placement goal.* The bill would prohibit a community college district or community college from recommending or requiring students to enroll in pretransfer level English or mathematics coursework, except under specified circumstances.

(3) This bill would require all new and continuing United States high school graduate students and those who have ~~completed a GED,~~ *been issued a high school equivalency certificate*, who plan to pursue a certificate, degree, or transfer program offered by a California community college, to be directly placed into, and, when beginning coursework in English or mathematics, enrolled in, transfer-level English and mathematics, as provided. By July 1, 2023, the bill would prohibit a community college district or community college from using specified factors as justification for placing a student in a ~~pretransfer level~~ *pretransfer-level* course.

(4) This bill would require the ~~Chancellor's Office~~ *office of the Chancellor* of the California Community Colleges, beginning July 1, 2023, to make available on its internet website a dashboard containing multiyear data, beginning from 2015, and updated annually, containing data submitted to the chancellor's office by community colleges on

student progression and completion of transfer-level English, mathematics, and English-as-a-second-language courses, disaggregated by college and subgroup, as provided. The bill would require, beginning December 1, 2024, and annually thereafter, the chancellor's office to provide a report to the Legislature with data from the dashboard, as specified.

(5) To the extent ~~the~~ *this* bill would impose additional duties on community college districts and community colleges, the bill would impose a state-mandated local program.

(6) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement. This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above.

(7) This bill would make Legislative findings and declarations, and state the intent of the Legislature, relative to these provisions.

The bill would authorize local educational agencies to also apply for one-time grants of up to \$100,000 to establish a CCAP partnership, as provided.

The bill would encourage each campus of the University of California, each independent institution of higher education, and each private postsecondary educational institution to conduct the same email outreach, as provided. The bill would require FAFSA data to only be used to inform students of their potential CalFresh Program eligibility.

*and request all University of California master's of social work programs, to require a student with a concentration in behavioral health to complete core competencies on working with the severely mentally ill.*

This bill would establish the California Student Housing Revolving Loan Fund Act of 2022 to provide zero-interest loans to qualifying applicants of the University of California, the California State University, and the California Community Colleges for the purpose of constructing affordable student housing and faculty and staff housing, as specified. The bill would establish the California Student Housing Revolving Fund as a continuously appropriated fund in the State Treasury, thereby making an appropriation. The bill would state the intent of the Legislature to

appropriate \$5,000,000,000 for purposes of the housing loans. The bill would require the California School Finance Authority and the California Educational Facilities Authority to submit a report, by March 15, 2024, to the Department of Finance and the budget committees of the Assembly and Senate containing information on the act, as provided. The bill would apply certain provisions of the California Educational Facilities Authority Act to the University of California and the California State University for purposes of housing projects, as defined.

This bill would declare that it is to take effect immediately as an urgency statute.

*This bill would specifically require each Basic Needs Center to also ensure that students have the information they need to enroll in the California Special Supplemental Food Program for Women, Infants, and Children (WIC). To the extent the bill imposes additional duties on community college districts, the bill would impose a state-mandated local program.*

By imposing additional duties on community college districts, the bill would impose a state-mandated local program.*

The bill would also require each campus of the California State University and of the California Community Colleges, and request each campus of the University of California, by no later than February 1, 2023, to host on its internet website, as provided, a student parent internet web page that includes information on all on- and off-campus student parent services and resources, as specified. By imposing additional duties on community college districts, the bill would impose a state-mandated local program. The bill would include legislative findings and declarations, and state legislative intent, relating to these provisions.*

**Senate Bills (SB)**

**SB 885 (Laird)** – Community colleges: Current and former foster youth support: NextUp.

This bill would rename the Cooperating Agencies Foster Youth Educational Support Program as NextUp, and would expand authorization for the program by removing the 20 community college district limit. The bill would instead authorize the Chancellor of the California Community Colleges to enter into agreements with community college districts to provide, and allocate to selected community colleges within a community college district, funds for services in support of postsecondary education for foster youth, and would make conforming changes. The bill would require a community college district that wishes to participate in the program to submit a letter of interest to participate to the Board of Governors of the California Community Colleges, as specified.

Existing law requires the board of governors to adopt regulations authorizing the director of the Community College Extended Opportunity Programs and Services at each community college to accept students who are enrolled in at least 9 units into the program.

This bill would authorize students enrolled in fewer than 9 units to be accepted into the program if enrollment is part of an ~~academic~~ *education* plan designed to move the students toward subsequent enrollment in at least 9 units.

This bill would instead authorize the chancellor to designate up to 1% of funds allocated to the program for program administration, program development, and program accountability.

**SB 886 (Wiener)** – California Environmental Quality Act: exemption: public universities: housing projects.

This bill would, until January 1, 2030, exempt from CEQA a university housing development project, as defined, carried out by a public university, as defined, on real property owned by the public university if the project meets certain requirements and the project is not located, in whole or in part, on certain sites, including a site that is within a special flood hazard area subject to inundation by a 1% annual chance flood or within a regulatory floodway as determined by the Federal Emergency Management Agency, as provided. The bill, with respect to a site that is within a special flood hazard area subject to inundation by a 1% annual chance flood or within a regulatory floodway, would prohibit a local government from denying an application on the basis that a public university did not comply with any additional permit requirement, standard, or action adopted by that local government applicable to the site if the public university is able to satisfy all applicable federal qualifying criteria in order to demonstrate that the site meets these criteria and is otherwise eligible to be exempt from CEQA pursuant to the above requirements. By imposing additional duties on local governments, this bill would impose a state-mandated local program. The bill would provide that a university housing development project is not exempt from CEQA if, among other things, the project would require the demolition of specified housing or a historic structure that is listed on a national, state, or local historic register. The bill would require the public university to hold at least one noticed public hearing to hear and respond to public comments before determining that the university housing development project is exempt under the bill's provision.

**SB 964 (Wiener)** – Behavioral health.

This bill would amend the act to require the California Community ~~Colleges, the California State University, and, if made applicable by the regents by appropriate resolution, the University of California, Colleges and the California State University, and to request the University of California,~~ to develop 2 accelerated programs of study related to degrees in social work. The bill would require one program to offer a concurrent bachelor's and master's of social work program that ~~will~~ *would* allow students to combine their last one or 2 years of undergraduate study in social work with their graduate study in social work in order to complete both programs at an accelerated rate. The bill would require the ~~second~~ *2nd* program to offer an accelerated academic program in which students with experience as peer support specialists, *registered or certified alcohol or other drug counselors*, community health workers, or psychiatric technicians could receive their associate's degree, as well as a bachelor's and master's degree in social work. The bill would require both programs to require a student to take a course on working with the severely mentally ill, with a focus on working in the public behavioral health system.

This bill would establish the Behavioral Health Workforce Preservation and Restoration Fund as a fund in the state treasury, to be administered by the department, for the purpose of stabilizing the current ~~licensed~~ *licensed, certified, or registered* clinical behavioral health workforce. The bill would authorize moneys from the fund to be used, upon appropriation by the Legislature, to provide hiring or performance-based bonuses, salary augmentation, overtime pay, or hazard pay to ~~licensed licensed, certified, or registered~~ professionals working in the behavioral health sector. The bill would also require the department to establish a stipend program, in addition to and separate from the fund, for students pursuing a master's degree in social work with a specialized focus on public behavioral health. Under the

bill, a student would be eligible for a stipend of \$18,500 per year for up to 2 calendar years if specified conditions are met.

**SB 1141 (Limón)** – Public postsecondary education: exemption from payment of nonresident tuition.

This bill would reduce, for purposes of eligibility for this exemption from paying nonresident tuition, the total years of full-time attendance in certain California schools, the years of full-time high school coursework in California, and the total years of attendance in California elementary schools and California secondary schools required from 3 or more years to 2 or more years, and would make a conforming change.

### BACKGROUND:

The Executive Committee will approve a program structure, discuss process for determining a theme, and begin planning for the 2022 Fall Plenary Session, held November 3-5, 2022, at the Sheraton Grand Sacramento Hotel.

Over the past year, the ASCCC has provided faculty access, engagement, and impact with our hybrid events. While the events have been successful, the cost has grown considerably. ### BACKGROUND:

Following the review and approval of the tentative operating budget at the May 6, 2022 Executive Committee meeting, the attached tentative budget for 2022-23 fiscal year is being presented for discussion and adoption.

The Budget and Finance Operational Committee, comprised of the ASCCC president, vice president, secretary, treasurer, executive director, and accountant (as advisor), will meet in early August to update the budget and prepare the final annual 2022-2023 budget for ASCCC. Funding recommendations were based on current trends and recommendations by the 2021-2022 Executive committee, such as protecting reassigned time for Executive Committee members, maintaining staff salaries and benefits, maintaining program and committee budgets, and anticipating any recurrence of the COVID-19 pandemic through 2022. The tentative budget also includes projected numbers for the grants C-ID and OERI. A few changes from the May 2022 draft include:

#### Revenue:

- Membership dues: \$472,000 - 5% increase (instead of 3%)
- Curriculum - \$260,150 - adjusted for CI event attendance
- Governor's Grant - \$1,111,000 - adjusted with increase from 22-23 Governor's budget
- OER - \$1,121,641.25 - adjusted to reflect the Y5 grant budget
- Rising Scholars - \$100,000 - renewed for 22-23
- IEPI grant - \$132,000 - renewed for 22-23

#### Expenses:

- ICAS - increased from \$10K to \$20K - ASCCC hosting 22-23
- Senate Website - increased from \$10K - \$25K - additional work on website/maintenance
- Instructional Salaries Grant -NEW - \$109,200 - payments for OERI faculty
- Professional Services - increased from \$30K - \$75K -- includes Advocate payment and Ledgent staffing service for accounting clerk

### BACKGROUND:

Annually the Academic Senate for California Community Colleges calls for nominations for one of the two faculty seats on the Board of Governors. Candidates for nomination submit an [online application](#), statement of intent, current resumé outlining relevant professional activities, and the letter of local senate endorsement if applicable. Nominees are then selected and interviewed by the Executive Committee at its September Executive Committee meeting.

The process is outlined as follows:

**July:** The Senate Office will screen the applications for completeness. Incomplete applications will not be considered. Applicants whose applications are deemed incomplete will be notified and be invited to apply again in the future.

**August:** The President of the Academic Senate shall present draft interview questions for review and possible revision by the Executive Committee. To preserve the confidentiality of the process and to ensure fairness to nominees, the review and revision of interview questions will be conducted in closed session. The Officers and Executive Director will then screen the applications based on the required and desirable qualifications and determine the candidates for nomination to be interviewed by the Executive Committee.

**September:** All candidates, including sitting Board of Governors members, shall be interviewed by the Executive Committee to be considered for nomination to the Governor.

## ASCCC OERI August 2022 Update (8-1-22)

### • ASCCC OERI RFP IV (2022-2023) •

Funded in February of 2022, the projects selected in response to RFP IV are underway. All team members were required to participate in the OERI's two courses over the summer (ASCCC OERI: OER Basics and ASCCC OERI: Accessibility Basics). Webinars intended to support the projects – and the field more generally – were held over the summer. Most notably, a 3-part series on H5P was very well-attended. H5P makes creating interactive exercises simple and has provided an open homework solution for many disciplines. It also simplifies adding interactivity to any course or OER.

[California Education Code 78052](#) (j) specifies that “The chancellor’s office shall award an initial round of grants no later than January 1 of a fiscal year for which the funds are appropriated.” On July 29, 2022 [“Zero Textbook Cost Program – Overview and Guidance”](#) was distributed via email. It provides a brief background of ZTC in the colleges, recognizes the ASCCC-proposed section-level data element as a critical component of tracking instructional materials costs, states the Chancellor’s Office’s intent to convene a ZTC Taskforce, and announces that there will be a “Phase 1” of grants that will provide \$20,000 to colleges to “begin the development of a ZTC program.” A “Phase 2” will also be made available in the upcoming term.

The ASCCC OERI has been actively preparing for ZTC Program, documenting the courses (leading to degrees) for which OER are readily available and the ZTC degrees currently offered across the state. The ASCCC OERI has developed OER Collections for the California Community Colleges, organized by discipline, CSU general education requirements, Transfer Model Curriculum, and C-ID.

The ASCCC OERI looks forward to supporting the ZTC Program in the years ahead.

• **ASCCC OERI IDEA Framework** •

To support faculty as they implement a culturally responsive and anti-racist pedagogy, the Academic Senate for California Community Colleges Open Educational Resources Initiative, in response to Resolution 09.05 adopted in Spring 2021 ([Developing an Anti-Racism, Diversity, Equity, and Inclusion Curriculum Audit Process](#)), has developed a review framework to evaluate existing open educational resources to ensure that ASCCC OERI-supported open educational resources are inclusive, diverse, equitable, and anti-racist (IDEA). We’ve shared the IDEA Framework in many venues and in partnership with the [Institute for a Racially Just, Inclusive, and Open STEM Education](#) (RIOS Institute), we recruited faculty, from the California Community Colleges and beyond, to participate in a short-term project to improve to the [ASCCC OERI’s IDEA Framework](#). An updated version of the Framework will soon be released.

## • ASCCC OERI Report to the Legislature •

Although a little dated now, our [ASCCC OERI Department of Finance Progress Report](#) provides a useful overview of our work to date. Highlights include the following:

- Facilitated the awareness, adoption, and adaptation of OER through the hosting of over 135 general, discipline-specific, and tool-specific webinars that have been attended by over 2100 faculty. In addition, 56 webinars were hosted for local OER advocates (OER Liaisons).
- Identified – and supported - OER Liaisons at each of the colleges to ensure on-going communication between the OERI and local faculty and college colleagues.
- Created a website (asccc-oeri.org) to promote OER and simplify the identification of available OER by providing easy access to OER resources organized by discipline (27 comprehensive collections), general education area, and Transfer Model Curriculum (25).
- Established a team of over 30 Discipline Leads to curate existing OER and facilitate OER awareness and adoption.
- Initiated the formation of discipline-specific communities of practice to support faculty OER efforts.
- Developed a wide array of resources to support OER-related work, including two self-paced courses (OER Basics and Accessibility Basics), a series of OER “Quick Guides” on OER-related topics that can be accessed online or printed for local use, a variety of resources for OER developers, and an ever-expanding collection of resources to support local OER advocacy.
- Supported the creation of 63 new OER over three competitive funding cycles, with an emphasis on collaboration, meeting statewide needs, and sustainability.
- Developed a framework for reviewing and revising OER and other course resources to ensure that they are inclusive, diverse, equitable, and anti-racist (the ASCCC OERI IDEA Framework), which will be integrated into future OERI supported projects and used to review and modify existing resources.
- Tracked and supported the implementation of California Education Code 66406.9 that requires the colleges to identify Zero Textbook Cost (ZTC) course sections in their online course schedules.
- Collaborated with representatives from the California State University and the University of California to host Cal OER, a free OER conference intended to highlight the state’s OER/ZTC work and attended by over 400 faculty.
- Developed and piloted an OER/ZTC student impact survey to assess the impact of textbook costs and OER/ZTC materials on California community college students.

## • Student Voices •

The ASCCC OERI's Student Voices Project, led by the OERI Area B Regional Lead Heather Dodge, has produced [the OERI Student Impact Toolkit](#). The toolkit is designed to guide colleges, universities, and other organizations in higher education to capture, measure, and share the impressions and impact of Open Educational Resources (OER) and Zero Textbook Cost (ZTC) course sections on enrolled students through a survey and videos. The toolkit includes an editable survey, strategies for implementing the survey, examples of how to display and share the survey data, and considerations for ensuring campus stakeholders are involved. The second part of the toolkit includes a video library of example videos of students speaking about OER and textbook costs, sample video and image release forms, and guidelines for creating successful videos. These resources are all openly licensed (CC BY) and can be used, remixed, and re-shared.

### Measuring Student Impact: Capturing Student Voices in OER/ZTC

## • 2022 - 2023 •

As we begin a new academic year, we will be concluding our projects currently in progress, including the RFP III projects, our two facilitated projects (communication students and psychology texts), and the analysis of various surveys (e.g., discipline OER use, low-cost definitions). Our work on the IDEA Framework will continue, as will our efforts to facilitate local implementation of legislation, regulations, and policies related to the costs of textbooks. Increased student outreach is anticipated, as well as further exploration of open pedagogy as a means of maximizing the benefits of OER as a tool to foster student success.

# Financial Terms Review Sheet

ASCCC financial operations include the following:

- **Internal controls**--the ASCCC accounting department has established detailed internal operational procedures and policies.
- **Budget and Finance Operational Committee**--comprising the ASCCC officers and executive director is responsible for making recommendations to the Executive Committee for the annual budget for each subsequent year and making recommendations on fiscal policies and procedures.
- **Treasurer**--reports on a periodic basis to the Executive Committee.

## Standard Reports

A few of the standard ASCCC financial reports generated and distributed are as follows:

- **Budget forecast**--an annual written statement projecting the forecasted expenses and revenue for the following fiscal year; usually presented to the Executive Committee before the fiscal year begins (May/June).
- **Statement of activity**--the report showing the revenue and expenses to date; it can include the comparison to the budget forecast.
- **Statement of financial position**--the report showing the organization's assets (e.g., cash--receivables and reserves), total assets, liabilities (e.g., money we owe), net assets (e.g., the difference between liabilities and assets). This report may be given to the Executive Committee in the quarterly report; also called balance sheet.
- **Quarterly report**-- a summary that will have brief descriptions of income and expenses to date within overall categories and will be brought to Exec after accounting books close (approximately November/December, February, April/May, September/Audit Report).
- **Audit report**--summary of findings (e.g., opinions on the organization's financial procedures and statements) made by an external auditor brought to Executive Committee in November; to be distributed to the faculty body at fall plenary session.
- **Reconciliation reports**--treasurer and accountant work together to review bank statements monthly as oversight; includes review of money market account where reserves are held (six months of operational expenses).

### **• Cal OER August 3-5, 2022 •**

The 2022 Cal OER Conference will be held virtually on August 3 – 5, 2022. [Registration is now open](#) and [the program is available for review](#). To learn more about Cal OER, visit the [Cal OER website](#).

### **• New OER Available •**

The ASCCC OERI's 1<sup>st</sup> "facilitated projects" are in their final stages of review, revision, and refinement. [Biopsychology](#) and [Interpersonal Communication: Context and Connection](#) were developed by faculty teams that were recruited by the OERI. Both draft texts are now available in LibreTexts for consideration by faculty.

### **• Creative Commons Training •**

The open licenses that are used to identify resources as "open" are provided by [Creative Commons](#), a nonprofit that also provides training on their use. The ASCCC OERI is in conversation with another nonprofit entity that would like to provide an opportunity for a small group of people to earn the Creative Commons Certificate. To determine faculty interest in such a training, the OERI published a short survey in early June. Over 75 faculty responded. We're in the process of reviewing these data so that they may be used to inform next steps. We're hoping to be able to make training opportunities available during the upcoming academic year. As present, a week-long Creative Commons "boot camp" is likely to be held early January.

### **• OERI Seeking Discipline Leads •**

The ASCCC OERI is recruiting faculty to support our OER advocacy efforts by serving as Discipline Leads during the 2022-2023 academic year. The specific tasks of each Discipline Lead will be determined by the status of OER in the discipline. Each

Discipline Lead will serve as a resource for their discipline colleagues and will typically host at least one virtual event each term. Discipline Leads receive a stipend of \$500 at the end of each term upon completion of their specified tasks. Expectations and timelines for Discipline Leads hired late in the term will be adjusted appropriately.
