**2022-2023 ASCCC INSTITUTES AND PLENARY SESSION DATES**

**Approved December 6, 2019 Executive Committee Meeting**

MSC (Aschenbach/Curry) to authorize the office to contract hotels for Fall Plenary Session, Spring Plenary Session, Faculty Leadership Institute, and Curriculum Institute for up to five years in the future, taking into account the area rotation of Plenary Session and to authorize the office to enter into MOUs with partner organizations for institutes dependent on external funding.

MSC (Aschenbach/May) to approve a Thursday through Saturday day pattern for Plenary Sessions for the next five academic years.

**J. One Minute Executive Committee Member Updates**

Executive Committee members provided committee updates and any formal decisions that may be placed on future executive committee agendas for discussion/consideration.

**K. President/Executive Director Updates**

May provided a [written report](#). May reported on the work of the ASCCC for Undocumented Student Action Week. The theme this year is *Juntos Podemos*, with the event taking place on October 17-21, 2022. The week will feature a series of virtual webinars and on-campus activities to raise awareness about the challenges undocumented students continue to face and will feature solutions that support their educational dreams. May reviewed the three different pathways that are currently being vetted for consideration: proposed CalGETC pathway, proposed general education for associates degrees, and proposed lower division baccalaureate degree general education pathway, and noted that vetting for the three pathways will close at the beginning of October. Resolutions for the pathways are being considered for the upcoming plenary session.

May reported on the AB 1111 Task Force, which held its first meeting on September 29. Members received Bagley-Keene training, discussed the framework for the work of the task force, and reviewed numerous issues and considerations for the task force to consider as AB 1111 is implemented in the system. The AB 1111 Task Force is being co-chaired by the ASCCC and the CCCCIO, with the Chancellor's Office providing support and SOVA facilitating. The AB 89 Modern Policing Task Force is being pulled together and the ASCCC has appointed two discipline faculty to sit on the task force. Aschenbach is co-chairing the task force and dates will be established for the meetings. It was noted that the CCCCIO included the budget request from the ASCCC for funding for intersegmental transfer success collaborative in the 2023-24 budget request.

Mica provided an oral report. Patricia Carrillo will be starting in her role of Executive Assistant on October 3. The office is working on logistics and planning for the upcoming plenary session, with trainings held for Area Representatives on how to use Zoom Events for the upcoming Area meetings in October. The ASCCC website is being reviewed for accessibility and clean-up of duplicate or old content. The ASCCC Communications Team is also working on branding of the ASCCC, and ensuring all senate websites have the ASCCC logo on the sites. The ASCCC has received many requests for local senate visits this fall, with the visits currently being coordinated with various members of the Executive Committee to present on numerous topics. The upcoming *Rostrum* will be released on November 2, with 10 articles included for this publication.

Mica provided an update on the request from the Campaign for College Opportunity regarding demographic data of the Executive Committee. The ASCCC is also working to release demographic data on the Executive Committee over the last five years, as a response to the ASCCC Strategic Plan, Goal 2.

### III. ACTION ITEMS

#### A. Legislative Update – 20 mins., Aschenbach, pg. 41

Aschenbach indicated that September 30 is the last day for the governor to sign bills and highlighted bills that have passed or were vetoed on the [Legislative Report](#). Bills of note that passed are: AB 190 - Higher education budget trailer bill; AB 1232 (McCarty) - Community colleges: nonresident tuition fees: English as a second language courses; AB 1998 (Smith) Community colleges: nonresident tuition fees: Western Undergraduate Exchange; AB 2449 (Blanca Rubio) Open meetings: local agencies: teleconferences; AB 2459 (Cervantes) Postsecondary education: student housing: data collection; AB 2683 (Gabriel) Postsecondary Education: sexual violence and harassment: training and resources; SB 1141 (Limon) Public postsecondary education: exemption from payment of nonresident tuition. Aschenbach and Wada submitted a *Rostrum* article for the November edition to address the newly passed AB 2449 legislation to provide guidance to local senates on open meetings. Aschenbach noted that two bills were vetoed by the Governor: AB 1856 (Medina) Community college part-time employees; and SB 964 (Wiener) – Behavioral health.

The committee was informed of the progress on the January 11, 2023 Meet and Greet, with potential invitees to be generated after the November elections, and a training will be held for Executive Committee and Legislative Advocacy Committee by Webster prior to the event.

No action by motion was taken on this item.

#### B. Mission, Vision, and Values Statements – 15 mins., Mav, pg. 42

The Executive Committee considered the recommendations from the September 15-17 Executive Committee on revisions to the proposed Mission, Vision, and Values Statements. A suggestion was made to change the language slightly on the Vision statement to from “committing to” to “advancing”.

**Curry/Stewart (MSC) to approve revisions to the Mission, Vision, and Values Statement with the added change to the Vision statement to change “committing to” to “advancing”.**

#### C. Acronyms - 15 mins., Mav/Mica, pg.43

The Executive Committee reviewed and provided feedback on the newly formatted list of acronyms to be posted on the ASCCC website. Members commended the work of Morse and liked the overall direction of the acronyms list. Suggestions were made to include in the opening paragraph that local colleges may have their own list of local acronyms, and members provided additional acronyms to consider adding to the list. Members discussed the request

to consider the removal of some of the older acronyms, and suggested that older acronyms be kept in the event that documents that reference the older acronyms are used. Mica will gather any additional acronyms to add to the list via a Google doc.

**Curry/Arzola (MSC) to approve the structure of the acronyms list and to give gratitude to Morse and ASCCC Office for the work on the list.**

**D. [2022 Fall Plenary Session Planning - 30 mins., May/Mica, pg.62](#)**

The Executive Committee reviewed and considered for approval the 2022 Fall Plenary Session program. May reviewed timelines and due dates with the committee and made adjustments and revisions to the program. May noted that all presenters must be approved by the President and the Executive Director. Executive Committee members identified as the lead for the presentation are responsible for communicating with the President and Executive Director on the presenters, breakout session and general session descriptions, and are responsible for meeting timelines. It was requested that Executive Committee members leading the breakout and general sessions provide draft titles by October 2.

**Aschenbach/Curry (MSC) to approve the final agenda with revisions from the meeting.**

**E. [ASCCC Fall Plenary Resolutions – Draft 2 - 60 mins., Bean/Arzola, pg.64](#)**

Bean provided an overview of the Resolutions process and discussed with the Executive Committee the approval of the submitted resolutions for the pre-session packet for the upcoming Area meetings. Bean discussed with the committee the plan of the Resolutions Committee for presentations at the Area meetings; each Area will have a member of the Resolutions Committee attend to make the presentation. May requested an additional Executive Committee member to attend the Area B meeting, and Wada volunteered. The Executive Committee reviewed the draft resolutions to determine what will be moved forward and included in the pre-session packet. There were two submitted resolutions that were not forwarded to the Area meetings, as questions remained from the Executive Committee.

**F. [2023 Curriculum Institute Theme - 15 mins., Parker/Reese, pg. 65](#)**

The Executive Committee discussed and considered for approval the 2023 Curriculum Institute theme. Parker noted that the Curriculum Committee met to discuss the proposed theme. Members suggested slight changes to the proposed theme but noted overall that the direction of the theme is a promising one for the institute.

**Stewart/Curry (MSC) to approve “Delivering on the Promise of Higher Education through Curriculum: The Mission of the California Community College” for the Curriculum Institute 2023 theme.**

**G. [ASCCC Academic Academy - 20 mins., Bean/Parker, pg. 66](#)**

The Executive Committee deliberated on the proposed dates for the 2023 Academic Academy, as well as discussed the potential for inviting two keynote speakers for the event, Imad Mays and James Gallagher. There was general agreement that it be imperative that experts in the field of mental health and trauma are presenting the information. As such, there was general support from the committee regarding the two proposed keynote speakers, and May and Mica will make the final decision on approval of the speakers. Members also suggested that the academy end early on Friday to recognize that colleges may close early due to the Presidents Day holiday.

**H. [CCC Advocate Award for Assemblymember Jose Medina - 15 mins., Reese, pg.67](#)**

The Executive Committee considered for approval awarding the CCC Advocate Award to Assemblymember Jose Medina. There was resounding support from the Executive Committee to provide the award and members discussed the venue in which the award will be given.

The Executive Committee discussed and considered approval of the request from Merced College to record the local senate visit on October 21. Members deliberated on the request, weighing pros and cons of the recording, including whether the visit is happening in conjunction with a senate meeting, which would negate the existing ASCCC recording policy, as the Brown Act allows local bodies to be recorded by the public.

Vélez informed the committee that the Foundation Directors recently held their orientation on September 28. The directors discussed various topics including the history and governance of the Foundation; expanding the

program goal of the Foundation beyond providing scholarships for professional development to include providing honoraria for presenters at ASCCC events; expanding fundraising efforts and sponsorship efforts at events; and the future strategic plan for the Foundation. The Foundation will provide an update to the field at the Area meetings and at Plenary.

**ii. Liaison/Caucus Reports - 5 mins. each, May, pg.69**

The Executive Committee will receive oral or written reports from liaisons or representatives from partner organizations and ASCCC Caucuses.

David Williams, CCCCIO provided a [written report](#). The CCCCIO Fall Conference will take place on October 17-21 in San Diego and Williams highlighted the board's goals for the 22-23 academic year.

Mac Powell, ACCJC provided an oral report. The ACCJC had a listening tour to amend accreditation standards and proposed new revisions to the standards as a result of the listening tour.

Dan Crump, CCL provided a [written report](#). Crump shared the concern of the library faculty on the revised ACCJC standards and a small working group was convened to work on a resolution to be submitted for adoption at the Fall Plenary Session.

Alyssa Nguyen, RP Group provided an oral report. The RP Group is releasing their EOPS report. The RP Group has upcoming webinars on throughout of students with disabilities, as well as a webinar on transfer success for African American students on October 26. This webinar will be accompanied by three reports with information on surveys on colleges with high rates of transfer for African American students.

**Background:** The Academic Senate provides support and assistance to local academic senates through both formal and informal mechanisms. As part of its ongoing mission to strengthen and support the local senates of all the California community colleges, the ASCCC offers opportunities for college visits to provide professional development and technical assistance. All requests for college visits by the ASCCC must be approved by the college senate president. The ASCCC currently offers the following types of visits: Accreditation Resource Teams, Guided Pathways Resource Teams, Local Senate Visits, Technical Assistance – Curriculum, and Technical Assistance – Governance.

There are instances where one visit to the college may not suffice and colleges need ongoing support to resolve issues or affect change on their local senate, campus, or district. The ASCCC is proposing a model, called the Coaching Model, which provides local senates and local leaders sustained expertise and support from the ASCCC to assist in resolving local issues.

The attached document was presented and reviewed during the November 2020 Executive Committee meeting, and at that time, the Executive Committee requested Relations with Local Senates modify the plan. Since then, faculty members who have conducted coaching services for colleges were requested to review the draft document and make suggested edits and changes to better reflect some of the processes that they have followed in the interim, prior to the formal approval of the document.

The Executive Committee is being asked to review and consider for approval the ASCCC Coaching Model.



## **ASCCC Coaching Model: Providing long term support to local academic senates**

The Academic senate for California Community Colleges (ASCCC) has long provided support to local academic senates in governance through resolutions, professional development, papers and publications, and presentations at conferences and institutes as well as at local colleges. One major support the ASCCC provides to local academic senates takes the form of the local visits. Executive Committee members and members of the ASCCC standing committees visit local colleges to listen and advise on a variety of issues including governance, curriculum, guided pathways, or any other area pertaining to education code or title 5 including the 10+1. The ASCCC also engages with other stakeholder groups to do more focused sessions, such as with the CCLC in Collegiality in Action visits. Generally, one or two stand-alone visits provides the information and support local academic senate leaders need to move forward in resolving issues and effecting change in their academic senates, colleges, and districts. However, there may be situations when one or two visits is not enough to make the lasting changes required or reach an identified goal. In those cases, a sustained coaching model may be better suited to achieve desired results and provide the support local academic senates need to work through conflicts or areas of growth at the college.

### **ASCCC Coaching Model**

A model that provides local academic senates and local leaders sustained expertise and support from the ASCCC to assist in resolving local issues.

#### *The process:*

1. Request Assistance: The local academic senate president, or another local academic senate leader in collaboration with the academic senate president, requests assistance from the ASCCC. Areas of assistance could include but are not limited to: governance, equity, curriculum, accreditation, guided pathways, faculty diversification, pre-transfer reforms, noncredit, OER, academic freedom, and union/academic senate relations.
2. Needs Assessment: The ASCCC President or designee contacts the academic senate president and academic senate leader, if appropriate, to gather more information on the issue that is at hand.
  - A. This is a structured conversation to determine not only the obvious issues but also what may be impeding progress including differing perspectives, areas of conflict, and points of disagreement.
  - B. The ASCCC President, or designee in consultation with the ASCCC President will document findings from the needs assessment and make recommendations on how to proceed including:
    1. Identifying possible ASCCC representatives taking into consideration certain knowledge and skills:
      1. Content expertise
      2. Equity and cultural competencies
      3. Facilitating dialogue
      4. Conflict facilitation and resolution

- C. Type of possible contact needed with the local academic senate and/or the academic senate president or local leader:
  - a. Weekly
  - b. Monthly
  - c. Bi-monthly
- D. Length of time: Semester or Year
- E. The ASCCC President or designee will also inform the college representatives that there may be a charge for the coaching and request information regarding funding for compensation for this coaching.
- 3. ASCCC President Appoints: Based on the recommendation, the ASCCC president appoints two individuals to begin the process. To appoint coaches, the ASCCC president may draw from the experience of the following:
  - F. ASCCC present and past Executive Committee members
  - G. ASCCC present and past Standing Committee members
  - H. ASCCC leads, consultants, caucus members, and others with an official relationship with the ASCCC.
- 4. Coaches complete the following process:
  - I. Deeper Analysis: Investigation into the issue with separate meetings with faculty holding different perspectives
  - J. Overview presentations on local academic senate role, academic senate leaders, and faculty roles as they pertain to the issue at hand.
  - K. Facilitated dialogue with faculty, local academic senates, local senate executive team, or others to discuss findings, analysis, and possible actions to address issues.
  - L. Follow up with a written advisory report to the local academic senate on key issues, recommendations on addressing the issues, and suggestions on who might be responsible for implementing solutions.
  - M. Discussion of the report with local academic senate president, stakeholders and interested parties, as appropriate. Adaptations are made to the report as necessary.
- 5. Create a Plan: A plan of coaching activities designed to help local academic senates and leaders implement actions to move toward solution or desired results is submitted to the ASCCC president and local academic senate president. The plan includes the following:
  - N. Final advisory report
  - O. Type of coaching contact:
    - a. Individual mentoring of the academic senate president or academic senate leader (i.e., curriculum chair, guided pathways lead, accreditation lead, etc.)
    - b. Meetings with local academic senate or local committee where the issue resides (i.e., curriculum, guided pathways, union/academic senate group, etc.)
    - c. Meetings with local academic senate executive committees
    - d. Any combination of the above.
  - P. Timeline of coaching activities
  - Q. The plan may change and adapt as the coaches work with the local academic senate and leaders. The coaches must keep the ASCCC president informed of the

progress and any changes necessary in the process to support the local academic senate.

**Issues affecting others at the college:**

In some cases, it may be beneficial for the ASCCC to partner with chief instructional officers (CIOs), chief student service officers (CSSOs), the Community College League of California (CCLC), or collective bargaining colleagues, as well as the Student Senate for California Community Colleges (SSCCC) to address issues that are confounded by processes or relationship with local college administration, classified professionals, union, or students. These issues may fall within the 10+1, subject to participatory governance, or are shared with bargaining units. In those cases, the Executive Committee member would identify the need and the ASCCC president would reach out to their counterpart at the appropriate organization to determine if it would be willing to assist. In doing so, the partner organization would reach out to their member at the local college to ensure that the support is welcome. If the partner organization agrees, then the above process would be followed with the partner organization as well as the ASCCC, and be advised of all progress with the college with the following adaptations:

6. Coaching appointments:
  - a. ASCCC Coach
  - b. Partner organization coach
7. Facilitated dialogue would occur separately with faculty, classified professionals, and administration to identify issues and obtain various perspectives and interests.
8. Coaches would write an advisory report including an outline of the issues and various interests and perspectives, an analysis of the issues, and possible actions to address the issues.
9. Leaders of both organizations will be apprised of all the information, plans, activities, and results from the coaching team.

**Compensation for coaches:**

Depending on the length and intensity of the coaching activity, it may be part of an assignment such as in the case of an executive committee member. If it is not a current executive committee member, then ASCCC would discuss compensation with the individual. Individuals not under contract with the ASCCC may contract directly with the college, but keep the ASCCC president apprised of the progress.

In response to Resolution 18.01 (Fall 2020), which calls for “the Academic Senate for California Community Colleges, in collaboration with system partners, [to] write a paper on optimizing student success by evaluating placement in English, English as a Second Language, and mathematics pathways for consideration at the Spring 2022 Plenary Session,” the ASCCC formed the Data and Research Task Force (DRTF) to write the paper. Separate surveys for English, Math, and ESL were administered in Spring 2021. The DRTF submitted a draft outline for approval at the May, 2022 Executive Committee meeting.

The Current Data and Research Committee (DRC) has reviewed the survey data and the previously-approved outline, and is suggesting a more narrowly-focused paper on Math. In addition, the DRC is looking for guidance (in light of our paper) on whether to forward a position paper, white paper, or other form of guidance to meet the intent of the resolution.

Christopher will meet with ASCCC Executive Director Krystinne Mica this week to discuss a FELA proposal for the coming academic years. He will introduce two timelines for cohorts. One cohort for this year academic year and beginning this October and the second for the '23-'24 academic year. The idea is to see how this academy would work in a one-year structure/cycle and to make sure that when we finish our work this year, next year's committee will be able to continue the work seamlessly.

Christopher shared a document with mission for FELA, along with his vision for the '22-'23 cohort in regard to timeline, outcomes, and program requirements and asked for input from the membership. Anna expressed concern in the number of "paid" events that cohorts would be required to attend. Christopher clarified that the list of "program requirements" was from the previous FELA and not one that needed to be included this year. He also suggested replacing them with "cohort summits". Summits should focus on practical solutions to challenges. Other activities include attending plenaries, attending at least one ASCCC executive committee meetings, and two other ASCCC related events. Christopher asked for input from members. Members agreed that Christopher's proposal improves upon FELA. Suman remarked that the CTA has a similar program and offered to share some of the resources from it. Christopher agreed that they could serve as good samples.

Christopher suggests that we focus primarily on getting this year's cohort up and running before placing more focus on next year's cohort. He discussed the timeline for the second cohort with May-June as the recruitment period and the cohort beginning its work in October. Elizabeth expressed concern that communication between cohorts may not be robust and this may lead to feelings of isolation or solitude. Christopher agreed and offered suggestions for ways to engage cohorts in "multi-conversations" or other types of community interaction. Christopher asked the membership if they're comfortable with the timeline. The membership indicated their support overall. Christopher stated that a cohort of 8 to 10 members would be great. Based on this, members stated that they believed this timeline is reasonable. Suman suggested that we add more summits to allow the cohorts to interact with each other. Suman suggested that a breakout session at a plenary or ASCCC institute be organized where cohort graduates can share their experiences. Christopher agreed and said this could definitely happen once we have a consistent program up and running. Christopher encouraged the members to continue to share their ideas and suggestions on the Google shared folder.

7) Future Agenda Topics

Possible Rostrum Articles (next submission is January 2023): Christopher said he will begin working on an outline for a Rostrum article on New Faculty Orientations/Institutes. Christopher will also begin working on a draft for the plenary breakout description and title.

- d. ASCCC Cultural Humility Plan

- II. Welcome and Introductions - Ginni provided background on the committee’s work, and how and why it was developed. Last year there was a taskforce and there is a paper to finish this year as a full-blown committee.
- III. Review Committee Charge  

The charge of the Data and Research Committee (DRC) is to assist local academic senates in using data effectively to evaluate educational programs and services to improve teaching, learning, and student success. The DRC will work with ASCCC Standing Committees, task forces, and other workgroups to establish and improve data-driven processes to advance inclusion, diversity, equity, anti-racism, and accessibility (IDEAA) in areas of academic and professional matters. The DRC may also conduct data analyses to assess the effectiveness of statewide issues and initiatives in areas of academic and professional matters.
- IV. Background: The Data and Research Task Force - Craig reviewed the work of the Taskforce last year, which was the result of a resolution to look at factors other than throughput. The committee prepared a survey sent to colleges to find what they are measuring. There is an adopted outline for the paper, but it relies upon the survey responses which were limited. The Taskforce constructed and deployed a survey and analyzed some of the work. The committee will need to determine what data is still needed. Given other publications and the singular focus on throughput, alternative data would need to be robust and convincing. There was a discussion about ways to improve the data set.

Ginni defined Hyflex as teaching where students have flexibility to go or do online and teachers are doing both for the same class. Some colleges have had success and some have not had success with this modality. Not clear on online being synchronous or non-synchronous.

    - i. Focus on the new data ASCCC has collected with the goal of presenting the measures in the survey as alternatives to looking at throughput. Use this paper as a professional development piece to collect more data for follow-up papers.
  - b. Follow-up papers could be on a series of topics, and they may potentially separate the data for Math, ESL and English.
