



  - Changes in CA Congressional Delegation

#### ASCCC Role in Legislation Development

- Normally we have not written or sponsored legislation
- Participate on CCCCO Legislative Program Task Force
- Suggest ideas for inclusion in legislation to other constituent groups (FACCC, CCLC, CCCCO)
- Consult with other constituencies to refine legislative proposals

#### ASCCC Role in Legislative Process

- Participation on CCLC Advisory
  Committee on Legislation
- Testify at Senate and Assembly Hearings
- Write letters to Senate, Assembly, and Governor as appropriate
- Lobby days—ICAS and BoG
- Consult individually with Senate and Assembly members
