How Can You Help (continued)

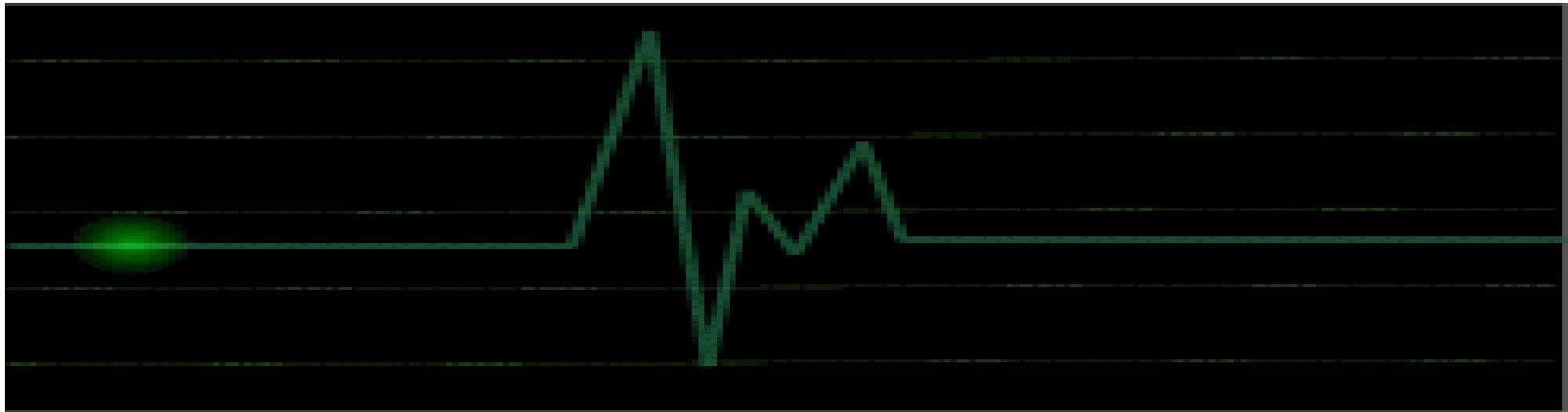
- Participate in Senate Deliberations and Develop the Collective Wisdom:
